Is a Higher Socioeconomic Status (SES) a Determinant For Domestic Violence?

Introduction

•Emergency services attend 200 domestic violence situations daily—that's 1 every 7 minutes!

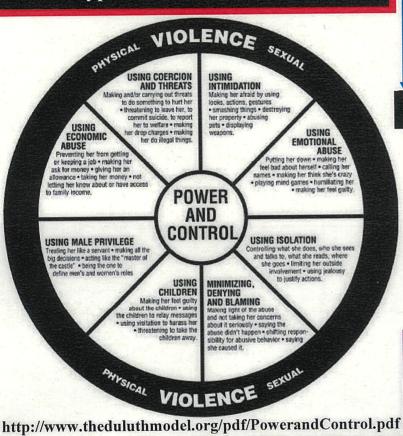
(National Collective of Independent Women's Refugees Inc., 2014)

•On average, 6 men, 14 women and 7-10 children are killed by a family member or someone entrusted in their care every year. (NZ Government, 2012)

•In 12 months, Child Youth and Family received 4,766 neglect cases, 3,249 physical abuse cases, 1,396 sexual abuse cases, 12,114 emotional abuse cases and 3,884 cases of children living in out-of-home care. (NZ Government, 2012)

Clinical Issue

- ⇒ Why is domestic violence poorly represented in high SES communities as a public health issue?
- ⇒ Abuse should be acknowledged in all spheres of society and not stereotypical of a lower SES

Conclusion

Domestic abuse stems from multiple determinants

By encouraging all aspects of a social climate to understand, acknowledge, discuss and report abuse, we can reduce the occurrence of domestic violence and emphasise that it is a significant health concern which is not to be tolerated—at any level of society.

Research

1. A comparison of abuse in Jewish (high SES) and Arab (low SES) school communities:

Jewish Schools	Arab Schools	
No relationship between SES &	Higher levels of abuse by lower	
Higher levels of reporting all variations of abuse	More reports of physical abuse and threats	

SES is not always a risk factor for violent behaviour (Khoury-Kassabri, Benbenishty, & Astor, 2005, p. 175)

2. "the fewer resources a woman has, the less power she has; therefore, she is less likely to leave the abusive relationship"

(Awang & Hariharan, 2011)

A high SES does not always require 2 incomes, leaving 1 financially dependent partner



Potential for inability to leave an abusive environment
